100 Nursing Homes Have Reported That They Are Now In Compliance With The Governor's Emergency Rule

TALLAHASSEE, **Fla.** – Today, the Agency for Health Care Administration (AHCA) announced that 100 nursing homes have reported that they are now in compliance with the emergency generator rule. Governor Scott called on the AHCA to issue the emergency rule in September to ensure the safety of Floridians in health care facilities during emergencies. The emergency rules require nursing homes to obtain ample resources, including a generator and the appropriate amount of fuel, to sustain operations and maintain comfortable temperatures for at least 96-hours following a power outage. Facilities who are not in compliance by the November 15, 2017 deadline will be sanctioned \$1,000 per day not in compliance, and possible license revocation.

AHCA Secretary Justin Senior said, "I would like to thank Governor Scott for his leadership on this issue and for working to make sure patients and residents living in nursing homes and assisted living facilities are safe when the facilities experience prolonged power outages. Our Agency has worked with facilities and various health care associations to answer any questions as we all work to our shared goal of patient safety. We thank the 100 facilities who have reported compliance, and our agency will hold the facilities who fail to do so accountable through fines or possible license revocation. It is unfathomable that someone would risk the lives of the patients and residents they serve because of cost. The cost of non-compliance is possible loss of life, and that is a risk we are not willing to take."

Under Florida law, F.S. 120.542, some facilities have been granted a one-time conditional waiver to provide additional time for the legal permitting and construction processes. It is expected that all facilities will be in full compliance by the beginning of the 2018 hurricane season, June 1, 2018. Those facilities not in compliance will face fines and possible license revocation. All waivers will be based solely on construction and permitting timelines, and no facility will receive a waiver due to cost. Each variance request must contain: steps the nursing home has taken to implement the rule, specific circumstances beyond the facilities control that have prevented full implementation, what arrangements have been made to fully implement the rule, a plan to inform residents and their families of the variance request, and an estimated time of full compliance with the rule. Each request will be thoroughly reviewed for consideration by AHCA. If facilities meet the stringent threshold to get a waiver, the state is required to grant the variance under Florida law, F.S. 120.542.

All facilities impacted by the emergency rule must inform patients and their families of their status of compliance. In addition to this, the Agency will post online the status of compliance for all facilities. AHCA has begun the formal rulemaking process to permanently enact rules requiring generators at nursing homes, and is working with the Florida Legislature to further protect patients. In addition, Governor Scott also asked the Constitution Revision Commission

(CRC) to consider proposals that would strengthen the Florida Constitution to protect those who live in nursing homes and assisted living facilities and find more permanent measures to put patient safety first as the CRC proposes changes to the Constitution.
