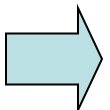

- **Expand Dental from 5 to 6 DTR's**
- **Add Pharmacy, Radiology and Fast Track**
- **Renovate existing clinic**



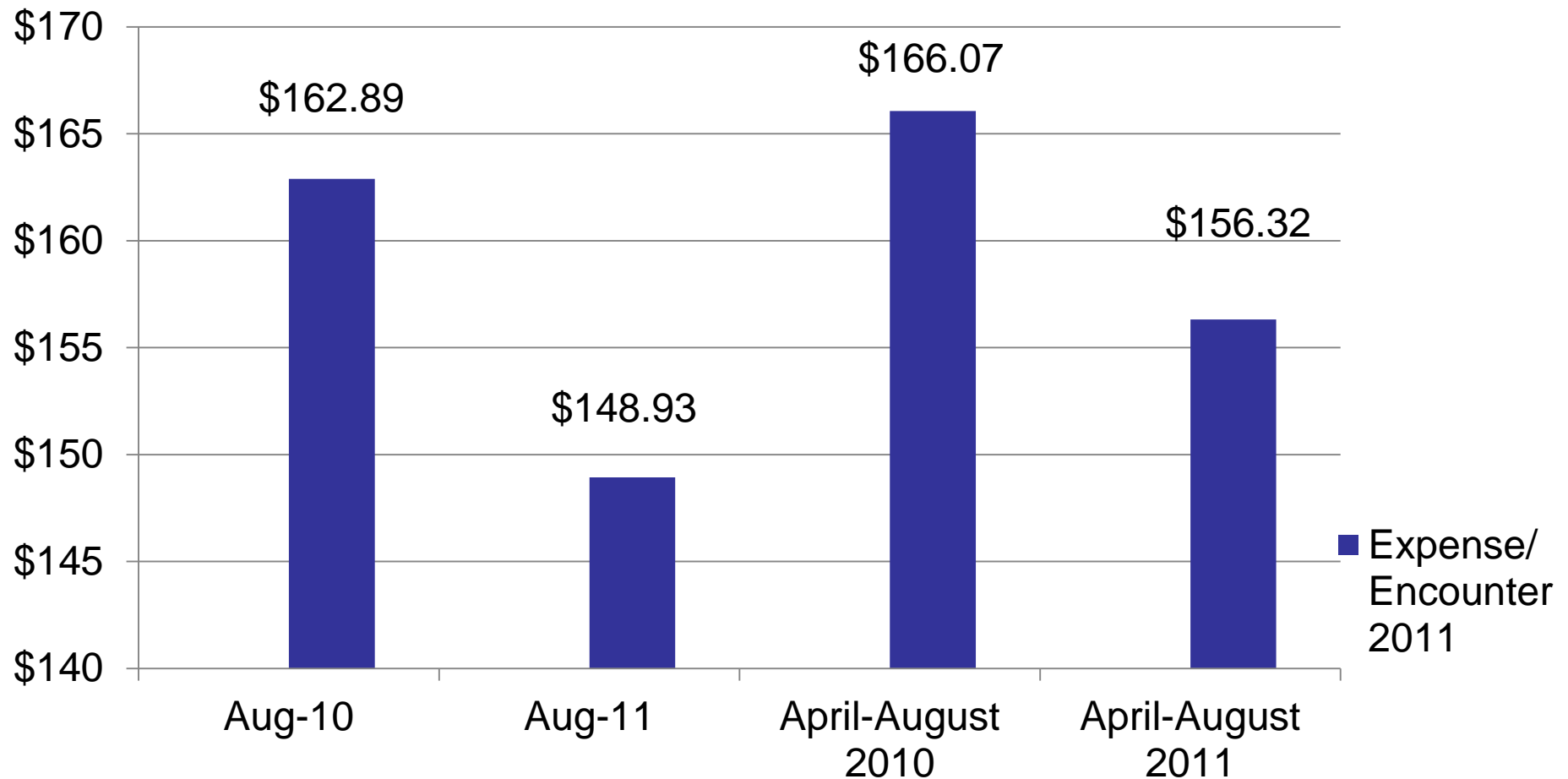
LIP Primary Care Funds

Funding Sources

The Center's annual budget exceeds \$22 million.

Funding sources from operations include:

Medicaid, Medicare, Hillsborough County Health Care Plan, Private Insurance, Patient Pay (discounted), and Federal Grants.

Additional limited funding comes from charitable contributions and center fund raising events.
