

#### 2015 Health Information Exchange RFI Process


- The RFI was posted June 29, 2015 with a response deadline of July 15 subsequently extended to July 22, 2015
- The purpose of the RFI is to determine vendor interest in Florida HIE and options for a possible future procurement
- The RFI will not result in a contract
- Responses were received from thirteen organizations

# Summary of Responses by Respondent Cognizant/ InterSystems


- Recommends independent NFP governance structure
- Proposes centralized data with MPI including
  - Provider portal
  - Integration with EHR
- Proposes use of patient data platform to generate event notifications
- Recommends opt out with filtering of sensitive data
- Option to support existing infrastructure with possible cost reductions



### Summary of Responses by Respondent Harris/ Audacious Inquiry

- Would support standing up a NFP
- Proposes federated architecture with vendor customized gateways
- Proposes addition of provider portal for accessing ENS alerts and CCD delivery
- Supports current consent approaches for PLU (consent to access) and ENS (subscriber obtains consents as necessary)
- Possible patient portal






### Summary of Responses by Respondent Medicity

- Would work within an existing governance structure
- Proposes community health record (centralized) with MPI including
  - Provider portal
  - Integration with EHR
- Proposes use of patient data platform to generate event notifications
- Recommends opt in with additional administrative controls
- Possible patient portal






#### Summary of Responses by Respondent NetDirector

- Would provide outreach, subscription agreement and fee collection services
- Proposes cloud based exchange with data standardization

- Proposes cloud based ENS platform
- Recommends opt out with filtering or as determined
- Proposes lower transaction based pricing






#### Summary of Responses by Respondent Nitor Group

- Recommends forming an NFP with member dues
- Proposes standardized secure cloud services for PLU
  Provider portal
- Proposes using Direct transport to receive ADTs for ENS
- Recommends opt out with consents obtained from patients with sensitive conditions
- Patient PHR proposed






#### Summary of Responses by Respondent Orion Health/ Uber Operations

- Some administrative support
- Proposes replacement platform for PLU (option 1) or centralized platform (option 2)

– Provider portal

- Customization for ENS with CCD pushes to electronic medical record proposed
- Consent to access for option 1; opt in for option 2
- Patient portal optional
- Option 1 at current costs; additional costs for option 2






#### Summary of Responses by Respondent Strategic Health Intelligence

- Central repository with gateway
- Consent to access supported with additional consents for notifications and analytics






#### Summary of Responses by Respondent Utah Health Information Network

- Governance outsourced with UHIN or another NFP
- Proposes clinical portal for HL7 messages
   CCD/C-CDAs to be added
- Proposes use of HL7 platform to generate event notifications with CCD delivery
- Opt out with filtering recommended

- Some administrative support and outreach
- Proposes centralized data with data formatting
  - Provider portal
- Centralized ENS portal
- Continue consent to access






#### Summary of Responses by Respondent Well Florida Council/RelayHealth

- Proposes centralized longitudinal patient record



# Summary of Responses by Respondent ZeOmega


- Some administrative support, analytics

- Availity declined to respond noting Florida HIE's permitted purposes policies
- Mosaica offered to assist the Agency in prioritizing the future direction of the Florida HIE by gathering stakeholder viewpoints
