# Florida HIE Quarterly Planning Report

## 1. Summary of Quarterly Activities

The following activities have been completed during the eleventh quarter of execution of the Florida Health Information Exchange (Florida HIE) program. This covers the period from November 1, 2013 through January 31, 2014.

During this quarter enrollment in the Direct Secure Messaging (DSM) service increased to over 9,000 registrants with over 7,600 exchanges of messages in January 2013. The development team continued to enhance the DSM software and deployed Release 5.1.3 during the quarter. Release 5.1.3 included storage cleanup and other maintenance activities. The team continued to work Health Information Service Provider (HISP) to HISP connections and connected the Wellogic HISP on November 20, 2013 and the Health Management Associates, Inc. (HMA) HISP on December 23, 2013.

The DSM development team worked on the administrative application design, continued work on database incremental backups and replication, and provided advanced support to DSM user issues. In addition the team worked on the Florida HIE Direct TrustBundle design to put it into production in early February.

The Event Notification Service (ENS) Pilot went into production on November 7, 2014 and started sending encounter alerts from Broward Health to WellCare health plan. There were 98 ENS transactions sent through DSM to WellCare and 30 summary emails sent to Broward Health in January.

The Patient Look-up (PLU) service is actively in use and produced 1,536 successful transactions during the month of January. The PLU deployment team continued onboarding progress with Martin Health, Department of Health (DOH), Community Health Systems (CSH) formerly known as Health Management Associates, Inc. (HMA), Senior Home Care, Florida Accountable Care Services, Naples Community Hospital, Bethesda Health, and Orlando Health. Additional progress was made on work to connect the Florida HIE to the eHealth Exchange (Florida HIE Gateway). The team met weekly with Healtheway and worked on the Integration State Gateway testing in the Harris Healthcare lab with UF Health to practice testing for onboarding to the eHealth Exchange. The team continues to make progress on the Social Security Administration (SSA) implementation and completed the Patient Consent Adapterlet code and worked on filtering codes so that only certain sites receive SSA queries. The team also facilitated the PLU Technical user Group meeting.

The Deployment and Outreach Subcontractors Health Management Associates, Inc. (HMA) and Strategic Health Intelligence (SHI)) continue making progress in their outreach efforts. HMA completed their HISP to HISP connection with the Florida HISP and made progress on

their PLU integration testing. SHI continued PLU integration with Covenant Hospice, Nemours and Baptist Medical Group.



# c) DSM Registrants and Transactions




