Re: Dental Plan Performance Measure Changes for July 1, 2024 Reporting (Measurement Year 2023)

The dental plan must collect data and report on the following performance measures, certified via a National Committee for Quality Assurance (NCQA) certified Healthcare Effectiveness Data and Information Set auditor. (Attachment II, Section IX.B.2.c., Table 4) The purpose of this policy transmittal is to notify the dental plan of changes in the performance measures for July 1, 2024, reporting.

Discontinued Performance Measure

The Agency-defined performance measure Dental Treatment Services (TDENT) will no longer be a dental plan performance measure. The dental plan shall continue to include the information in its Well-Child Visit Report submission, but the measure will not be calculated or used for contract compliance purposes.

Modified Dental Plan Performance Measures Table

The only changes to the performance measures for the dental plans are updates to the steward/source of the performance measures in Attachment II, Section IX.B.2.c., as indicated below:
