Welcome & Roll Call: Dr. Karen van Caulil called the meeting to order at 10:02 am. Karen asked Milly Hardin to read the Invitation to Negotiate (TTN) statement and to take roll. Ms. Hardin read the ITN statement:

"On Monday, May 6, 2024, the Agency released AHCA ITN 012-23/24, Statewide Health Information Exchange Service, in the Vendor Information Portal. Therefore, we are now in the statutory blackout period for this ITN. Section 287.057(25), Florida Statutes, prohibits any person from contacting an employee of the executive or legislative branches until 72 hours after the posting of an award from the solicitation. Any communication by or on behalf of a potential respondent during this period is strictly limited to the Procurement Officer as provided in the ITN. The Procurement Officer for this ITN is Weston McKain."

Ms. Hardin took roll and a quorum was present. Dr. van Caulil read the current mission statement and noted that she would like the Council to review and update the mission statement to better reflect current needs at the upcoming retreat.

Health Information Exchange Coordinating Committee (HIECC) Update: Craig Dalton gave the HIECC update. The HIECC met on November 13th. Mr. Dalton was re-elected as Chair and Dr. Kayvan Amini was elected as Vice-Chair. A question was raised about the ePrescribing report, and the Committee asked some questions about compound pharmacy participation, this topic will be further explored. There was a conversation about Emergency Patient Look-Up System (E-PLUS) patient matching and using the after-action report for targeted outreach to increase match rates.

- The BCPEP workgroup met in person on October 31, 2024 to review their recommendations
- The final BCPEP workgroup met November 21, 2024, to finalize their report recommendations, which is due by December 31

• Patient Safety Culture Survey Program

- The Patient Safety Culture Survey Program (PSCS) has transferred to the Office of Data Collection from the Office of Health Information and Exchange. The Agency is currently in the process of hiring staff to oversee the program.
- o The Agency's Patient Safety Culture Survey (PSCS) implementation is on schedule. The Agency is preparing for the inaugural PSCS data reporting period, June 1 through August 31, 2025. The system is regularly tested and the PSCS website is updated regularly with upcoming education sessions and the latest notifications from the Agency.
- The Agency works with Florida hospitals and ambulatory surgical centers (ASCs), their respective associations, and all interested parties to provide ongoing education sessions regarding the PSCS administration procedure and Agency expectations.
- The PSCS Team continues to be proactive in solution-based planning for potential disruptions in system functionality or use of the PSCS system. They are working with developers to automate the registration process and implement this year.

Office of Health Information and Exchange - Pamela King, Administrator

Health Information Exchange:

- As mentioned previously, the Agency is still in a blackout period for the invitation to negotiate (ITN).
- o The requested grant funding from the Centers for Medicare & Medicaid Service (CMS) to help support the E-PLUS system and the Florida Department of Health's (Florida Health) HIE system was approved for this Federal Fiscal year.
- A new Memorandum of Understanding with Florida Health has been signed to provide funds for their HIE system for the next 3 years.
- o A review was done of hospital National Exchange connectivity this is the current barometer used to determine overall ability for providers to exchange patient records data throughout the state. Hospital connectivity for National Exchange is currently at 71% – this includes psychiatric and rehabilitation hospitals. The hospitals connected make up 80% of the state's hospital beds.
- o The ePrescribing report for 2023 has been posted though there are limitations on the data available for these reports there is an increase in the number of eprescriptions; the percentage of eprescribers as of December 2023 is 106%. It is believed that this number is skewed due to telemedicine encounters.
- o There is a slight decline in the number of pharmacies that are receiving eprescriptions, going from 96% to 93% from 2022 to 2023. It is believed that this is due to pharmacy consolidation, but work will be done with the Florida Pharmacy Association to determine the cause.
- Eprescribing outreach efforts will be focused on the electronic prescription of controlled substances (EPCS) – however, there are increases here as well, with 73% of prescribers having enabled systems to EPCS and 92% of pharmacies enabled to





receive themThere was discussion regarding the reporting requirements, specifically whether eprescribing had met the intended goal and if the reporting requirement should be repealed. Staff will investigate and the Council will discuss at a later date.

• E-PLUS Program

o The E-PLUS program was activated for Hurricanes Debby, Helene, and Milton.

Ms. King reviewed a presentation around the E-PLUS Program. (a copy of the slides can be found on the website: State Consumer Health Information and Policy Advisory Council (myflorida.com). The Council discussed the benefits of having the E-PLUS Program for all Floridians.

Election of Chair and Vice Chair: Ms. Hardin let the Council know there were only two nominations for Chair, those nominated were Dr. Karen van Caulil who accepted the nomination and Dr. David Shapiro who declined his nomination for Chair but accepted his nomination for Vice Chair. Ms. Hardin then asked the Council if there were any nominations from the floor, no nominations from the floor were made. Ms. Hardin then asked the Council for a motion to approve Dr. van Caulil for Chair, and Dr. Shapiro for Vice Chair, by unanimous vote Dr. van Caulil and Dr. Shapiro will remain in their current positions.





Examining Data for Gaps

Assessment of Patients with Diabetes:

- Some patients with T2D less likely to be identified with algorithms using medication information and/or laboratory values relative to diagnoses
- Potentially the care/medication was not received or care provided through a non-OneFlorida+ partner
- Enhanced linkages will minimize the potential for an incomplete picture of patient care


How do we best identify and treat hypertension?

A

Hypertension is a modifiable risk-factor for cardiovascular disease, stroke and death.

- Affects 50% of adults over 45 in Florida
- Target interventions to people and places with greatest need
- Used Blood Pressure Information from OneFlorida⁺ Data Trust
 - No hypertension diagnosis
 - No identified antihypertensive medications
 - Large segments of potentially undiagnosed hypertension

- Trained using >1000 GPUs



Linking Patients to Cancer Clinical Trial withs Large Language Models



Eligibility Criteria

IN: The patient must have a diagnosis of metastatic colon-rectal adenocarcinoma.

Ex: Known comorbid medical conditions that would preclude investigational treatment (e.g., active hepatitis B or C: symptomatic cardiac disease; renal insufficiency; bone marrow impairment)
