#### **Executive Summary**

The Agency for Health Care Administration (Agency) is the chief health policy and planning entity for Florida<sup>1</sup>. Its responsibilities include, in part; health facility licensure, inspection, and regulatory enforcement including investigation of consumer complaints related to health care facilities and managed care plans.

Section 390.012(8), Florida Statutes (F.S.), directs the Agency to submit a report to the President of the Senate and the Speaker of the House of Representatives summarizing all regulatory actions taken by the Agency during the prior year on abortion clinics. Actions include licensure application reviews, inspections, collection of Induced Termination of Pregnancy (ITOP) reports, and administrative actions.

From January 1, 2024, through December 31, 2024, the Agency:

- Received 30 licensure applications;
- Conducted 167 on-site inspections;
- Received 100% of the required ITOP reports from licensed abortion clinics;
- Initiated 6 administrative actions.

#### Background

In Florida, an abortion may only be performed by a licensed physician<sup>2</sup> in a licensed abortion clinic, licensed hospital, or in a physician's office.<sup>3</sup> All abortions, regardless of facility or procedure type, shall be reported to the Agency.<sup>4</sup> The Agency is responsible for the regulatory oversight of abortion clinics and hospitals.

Pursuant to state law, the Agency issues an abortion clinic license to applicants meeting the minimum requirements found in Chapter 390, F.S and Rule 59A-9, Florida Administrative Code (F.A.C.). The law states that abortion clinics are authorized to perform procedures within the first trimester only unless the additional licensure requirements for second trimester procedures are met. An abortion may not be performed in any facility type after the gestational age of six weeks unless the conditions in section 390.0111, F.S. are met. Third trimester abortions and abortions during viability may only be performed in a hospital, and must also comply with the requirements in sections 390.0111 and 390.01112, F.S.

During calendar year (CY) 2024 Florida had 51 abortion clinics licensed to perform procedures located in 16 counties. For comparison, 52 abortion clinics were in operation during CY 2023. There were a total of 40 hospitals and 3 physician offices that reported performing procedures.

### **License Activity**

#### Applications

During the CY 2024, the Agency received 30 abortion clinic applications. Of those 25 applications were to renew existing licenses, 4 applications were to change existing licenses, and 1 application was for initial licensure. The change applications included 1 personnel change, 1 change of address, and 2 to terminate a license. There was 1 initial licensure application. No change of ownership (CHOW) applications was received.

In addition, in October 2024, the Agency issued a final order denying an initial licensure application for a new abortion clinic in Pensacola, Florida. The Agency found that the applicant's controlling interests had a demonstrated pattern of deficient performance based on their operation of an abortion clinic in another state.

#### Inspections

The Agency conducts an inspection for compliance with Chapter 390, F.S., and Rule 59A-9, F.A.C., prior to initial licensure and annually thereafter. The Agency also investigates complaints against abortion clinics and allegations of unlicensed activity. There were no allegations of unlicensed activity in 2024.

The Agency initiated 39 licensure and 128 complaint inspections at licensed abortion clinics during CY 2024 requiring 182 total on-site visits, including follow up visits, if needed. Deficiencies were identified during 19 of the licensure inspections and 10 complaint investigations. Refer to Table 3 for a list and frequency of the deficiencies identified during the year.

Upon notification of a deficiency, clinics have 10 calendar days to submit an acceptable plan of correction. The Agency reviews each plan to determine if the deficiencies are corrected. All deficiencies cited were corrected and no other action was taken by the Agency.

#### **Required Reporting**

#### Induced Termination of Pregnancy (ITOP)

All licensed abortion clinics must file a report each month summarizing the number of and reason for abortions performed during the preceding month. Hospitals and physicians must also report any abortions performed in their medical facilities and offices. The Agency posts year-to-date data, including previous calendar years on the Agency's website. The reports may be viewed at:

#### **Incident Reports**

Abortion clinics licensed to perform second trimester abortions must record any incident resulting in serious injury to a patient or viable fetus. The incident must be reported to the Agency within 10 days of its occurrence through a secure online portal. A serious injury is defined as one that creates a serious risk of substantial impairment of a major bodily organ. An abortion clinic must also report a patient's death to the Department of Health not later than the next workday. No deaths were reported during CY 2024. A summary of the incident reports include:

- Number of clinics reporting an incident: 7
- Number of incident reports received: 10
- Number of injuries reported: 14
  - Hemorrhage/excessive bleeding: 5
  - Perforation of the uterus: 2
  - Cervical injury: 1
  - o Other incidents that required specialized medical attention: 6

Note: Multiple injuries may be reported for a single incident, such as hemorrhage/excessive bleeding and any condition that requires transfer. Nine individuals were transferred to a hospital for follow up care.

#### Administrative Actions

The Agency may fine an abortion clinic up to \$1,000 for each class 1, class 2, or unclassified violation of chapters 390 or 408, Part II, F.S., or applicable rules, except for failing to timely file a monthly ITOP. That violation will result in a \$200 fine. Prior to levying a fine the Agency considers several factors, including:

- Severity of the violation (actual or potential harm to a patient);
- Actions taken by the clinic to correct the situation;
- The clinic's history of the same or similar violation; and
- The Agency's history of fine amounts for the same or similar violation.

Administrative actions taken by the Agency during calendar year 2024 include:

- Six ITOP late fines.
- Four license renewal applications were assessed late fees in accordance with s. 408.806(2)(d), F.S.
