The Agency for Health Care Administration (AHCA) is working to gather data related to Fair Rental Value (FRV). This data will be used by the Agency in the Nursing Home Prospective Payment System rate setting.

Completion of this survey is extremely important because the data you provide will be used in the prospective payment rate calculation. Please note that the data you provide is subject to Agency review and/or audit.

This data is due no later than April 30, 2020 for the October 1, 2020 rate setting.

If a facility fails to submit an FRVS survey by April 30, 2020, no change will be made to current building additions, replacements, renovation, or major improvement data in the FRVS calculation for the October 1, 2020 rate semester. Extensions will not be granted.

For providers who have already submitted survey results, please follow the instructions for approval of a prior submission, updating a prior submission (Option 2), or submitting changes to previously submitted data (Option 3). For providers who have not yet submitted survey results, please follow instructions for new submissions (Option 1).
