### **Electronic Visit Verification Implementation Date Changed to June 1, 2020**

**(For Behavior Analysis Services Provided in Regions 9, 10, and 11)**

The Agency for Health Care Administration (Agency) has delayed the mandatory implementation date for electronic visit verification (EVV) of behavior analysis (BA) services in Regions 9, 10, and 11 to **June 1, 2020**. The Agency is cognizant of the impact that the 2019 novel coronavirus (COVID-19) is having on providers in their efforts to ensure that recipients continue to receive timely care. This postponement will allow providers to have additional time to resolve any issues in using the EVV system.

As a reminder, in order to be ready by the mandatory start date of June 1, 2020, it is the responsibility of the group administrator to ensure that all rendering providers have unique contact information in the TELLUS EVV System.
