Florida Medicaid Health Care Alert April 1, 2020

Provider Type(s): 05, 10, 12, 14, 15, 65, 70, 91

Update: Providers can continue to bill fee-for-service for Medicaid services provided to recipients enrolled in Dual Eligible Special Needs Plans (D-SNP).

The Agency for Health Care Administration (Agency) will continue to allow your provider types to bill Medicaid fee-for-service until January 1, 2021 for Medicaid covered services not previously billed to the DSNPs.

Florida Medicaid recently submitted a Health Care Alert stating "effective January 2020 the Florida Medicaid Management Information System (FMMIS) no longer pays for any services billed to Medicaid for recipients enrolled in Dual Eligible Special Needs Plans (D-SNPs). Providers must bill all services to a recipient's D-SNP."

To give providers more time to complete network contracts, billing setup and training, and service authorization, the Agency for Health Care Administration (Agency) will continue to allow your provider types to bill Medicaid fee-for-service until January 1, 2021 for Medicaid covered services.

Recipients enrolled in DSNPs are dual eligible where Medicare is primary. Providers need to bill the DSNP for Medicare covered services. During this time, providers will need to continue to work with the D-SNPs to ensure that the transition from fee-for-service to the D-SNPs occurs seamlessly.

The Agency will continue to communicate with the D-SNPs to ensure their call centers are providing the appropriate information to Medicaid providers.
