Electronic Payment Option for Quality Assessment Fees for Nursing Facilities and Intermediate Care Facilities

Nursing Facility and Intermediate Care Facility providers are required to make monthly payments for the Quality Assessment in accordance with Sections 409.9082 and 409.9083, Florida Statutes. This alert gives guidance related to the option of submitting the Nursing Facility and Intermediate Care Facility Quality Assessment fees electronically.

For providers wishing to pay monthly Quality Assessment fees electronically, please contact Blaketon Rogers at <u>Blaketon.Rogers@ahca.myflorida.com</u> to obtain the necessary banking information. This banking information can be used for Electronic Funds Transfers, Automated Clearing House, and wire transfer payments. In addition to the payment, the signed Quality Assessment Fee invoice must be sent via email to Blaketon

Rogers at <u>Blaketon.Rogers@ahca.myflorida.com</u>. This is necessary so that Agency staff will be able to process and apply the revenue to the proper provider. Providers are encouraged to utilize the electronic payments option as the most secure and timely method of submitting a payment to the Agency.
