iBudget Provider Retainer Payments – Recoupment Process

The purpose of this alert is to notify Developmental Disabilities Individual Budgeting (iBudget) Waiver providers that the Agency for Health Care Administration (AHCA) and Agency for Persons with Disabilities (APD) have begun the recoupment process for providers that accepted a retainer (advanced) payment and also billed for services. As described in both the <u>April 3, 2020</u> and <u>May 6,</u> <u>2020</u> provider alerts, and as posted on the <u>AHCA website</u>, providers should not have accepted a monthly retainer payment and submitted claims for those same services during the month the payment was made.

Providers that accepted the retainer payment(s) and billed for services will be receiving a letter from AHCA notifying them that they have received an overpayment for Medicaid services. If you receive this notification, please follow the instructions in the letter to return any overpayments.
