## **Electronic Visit Verification (EVV) Implementation Date is December 1, 2020**

### **EVV Will Now Go Live December 1, 2020**

The Agency for Health Care Administration (Agency) is excited to announce the implementation date for electronic visit verification (EVV) for behavior analysis (BA) services is December 1, 2020 for the pilot Regions 9, 10, and 11. Providers must bill through the Tellus EVV System and must no longer bill via the Medicaid Provider Web Portal. Beginning December 1, 2020, claims that are billed through FMMIS will not be paid. Providers should act now to reorient themselves to using the Tellus EVV System and take advantage of the options outlined below for training and technical assistance.

### **Take the Following Actions to Ensure You can Receive Payment:**

#### Update Contact Information

- Verify that all rendering providers have current and unique contact information in the Tellus EVV System and in the Florida Medicaid Management Information System (FMMIS).
