**Statewide Medicaid Managed Care (SMMC) Policy Transmittal: 2021-17**

Applicable to the following benefits in the **2018-2023 SMMC contract**:

- Managed Medical Assistance (MMA) and MMA Specialty
- Long-term Care (LTC)
- Dental

**Re: Performance Measure Reporting Requirements Effective July 1, 2021**

The managed care plan and the dental plan must comply with reports required by the Agency as specified in the Managed Care Plan Report Guide. A summary of the reporting requirements is provided in the Summary of Reporting Requirements Table, Table 11, and that includes the Performance Measures Report. (MMA & LTC: Attachment II, Section XVI.A.3.; Dental: Attachment II, Section XVI.A.3.) The purpose of this policy transmittal is to notify the managed care plan and the dental plan of revised performance measure reporting requirements.

A revised Performance Measure Report Summary is attached to this policy transmittal. The changes include adding two reports and discontinuing two reports, as well as changing the due date for one of the five reports.

Discontinued

The following reports are discontinued effective July 1, 2021.

- Report Code 0141: Performance Measures Report – LTC & MMA
- Report Code 0206: HEDIS Record of Administration, Data Management, and Processes (Roadmap)

Added:

The following are new reports effective July 1, 2021.

- Report Code 0210: Performance Measures File Text format (HEDIS)
- Report Code 0211: Performance Measures File Text format (Non-HEDIS)

Due Date Change

The change in due date is only for report code 0143, which is now due July 15, for the prior calendar year. There is no change in the due date for report codes 0144, 0207, 0210, and 0211; these reports are still due by July 1, for the prior calendar year.
