Statewide Medicaid Managed Care (SMMC) Policy Transmittal: 2021-34
Applicable to the 2018-2023 SMMC contract benefits for: Managed Medical Assistance (MMA) and MMA Specialty Long-Term Care (LTC) Dental
Re: Dental Plan Performance Measures and Enrollee Satisfaction Survey Requirements for July 1, 2022 Reporting
The dental plan must collect data and report on the following performance measures, certified via a National Committee for Quality Assurance (NCQA) certified Healthcare Effectiveness Data and Information Set auditor. (Attachment II, Section IX.B.2.c., Table 4) The dental plan must contract with a qualified, Agency-approved, NCQA-certified survey vendor to administer the surveys. The minimum sample size is one thousand, six hundred and fifty (1,650), with a target of four hundred and eleven (411) completed surveys. The survey must be administered according to the NCQA mixed methodology (two-wave mail protocol with telephone follow-up of at least three (3) but no more than six (6) attempts). (Attachment II, Section IX.D.1.b.(1)) The purpose of this policy transmittal is to notify the dental plan of changes in the performance measures and enrollee satisfaction survey requirements for July 1, 2022 reporting.
Discontinued Performance Measures
The dental plan is no longer required to report on the following performance measure beginning with July 1, 2022 reporting, for calendar/measurement year 2021 services.

The dental plan must report on the following performance measure beginning with July 1, 2022 reporting, for calendar/measurement year 2021 services.
